Ca.) and are defined as "corridors identified by plaintiffs as having specific environmental issues." Corridor numbers correspond to those set forth in Appendix A of the Programmatic Environmental Impact Statement, Designation of Energy Corridors on Federal Land in the 11 Western States (DOE/EIS-0386, November 2008) and in the Records of Decision issued by the Secretaries of Agriculture and the Interior [Bureau of Land Management and U.S. Forest Service] in January 2009.
