Solar runs best at peak hours here in Sunny Southern California.** Let's preserve our forests and forget about pumping polluted Lake Elsinore water up an approx. 2,500 foot mountain which will destroy not only our public hiking recreation area, but will bring pollution to the water table. The warm water brought up to the colder mountain air will cause a fog to form over the upper reservoir which, when it drifts down Morrell Canyon, will create a dangerous condition for traffic on the Ortega Hwy. which will cause even more automobile accidents, law suits, etc., etc.
